

## Third Years Breakout Session

- Petition for students requesting to stay on-campus the whole year will go out this week
- Re: scurries, form will be sent out to students asking for information about their social groups
  - ◆ Social groups will not determine when someone is invited back to campus...if someone's friends are invited for a different term than they are, they won't be able to be in the same scurry because these are only determined after invites are extended and accepted
- Because first term is focused on first-years, second-, third- and fourth-years will receive a limited amount of invitations for the fall
  - ◆ Looking like most third and fourth years will be invited on campus starting in the spring, but determining who that is and for what term will be dependent on how the fall terms go
  - ◆ More second years will likely be invited for the second fall term
- Students studying abroad in the spring will likely not be on campus at all during the school year, but can perhaps enroll for the summer term
- Limiting off-campus permission, already extended more off-campus housing invitations than they expected to, anyone with specific questions can email Lauren Myers
- CA position has been eliminated, trying to rethink leadership roles and harm reduction, RLCs will likely take on some of the CA responsibilities
  - ◆ Still working towards ways to establish community, leadership, and connection
- Student employment questions should be fielded through Mark Watts
  - ◆ Student employment will not be a consideration for extending an invite, on-campus positions will be determined and filled after invitations have been accepted
- Financial aid will be available for summer terms
- You can interact with anyone else on campus, but will have to wear PPE if not with people in your scurry

- ◆ Face shields will be favored over faces masks, which will be provided to students in addition to multiple reusable face masks
- Students with items in C&K storage will potentially be able to have items shipped to them, looking into how storage can be reconfigured to accommodate longterm storage since students don't know when they will be on campus next
  - ◆ All storage items are currently either in Main Quad or off-campus facility
- Res Life is trying to honor Special Room Draw, no intention right now to place first years in those residences but that is still being determined and may occur depending on how living arrangements will be assigned
  - ◆ SRDs won't be a consideration in when someone arrives on campus, but they are trying to honor those invitations when a student who's been offered an SRD is back on campus
- Students living on campus will likely still take some classes online
- Don't anticipate that BEAR, Burling and Kistler will reopen...if so, definitely will be limited to students and won't be open to members of the public
- Decision to prioritize first years was because they are coming in with a completely blank slate, aren't at all acquainted with Grinnell and don't have a support system in place yet
- Only students living on campus will be billed the activity fee
- Students living on campus will only be able to eat in the dining hall during their scurry's scheduled meal time, but must have a full meal plan
- Spencer Grill won't be open as it has in the past, may be used to distribute grab and go lunches
- Reasoning for requiring full meal plan is to make demand more predictable for dining hall staff
- Access to cooking areas in residence halls will be limited because of public health concerns of cooking in shared spaces
